PRICING

Prices subject to change without notice. This pricing effective January 01, 2008 and replaces all previous pricing.

ORDERING

Freight is prepaid on all orders that include power units. All other orders must meet minimum of \$450.00 to obtain prepaid status. Excluding pipe. (Account must be within terms).

TERMS OF PAYMENT

Terms are cheque by return mail or Net 30 days. When invoices are not paid within terms, Easy-Flo reserves the right to charge interest as well as hold subsequent orders. First orders may require COD to establish credit.

RETURN OF GOODS AND WARRANTY ITEMS

All stock returns must receive approval from Easy-Flo Vacuum Systems Ltd. (please call 1-800-327-9356 or 604-792-8015). The purpose of "authorization" policy is that we can issue a **Returned Goods Authorization (RGA)** number. It is the dealers' responsibility to **return** the defective goods to the factory (or the warehouse in USA) **prepaid by mail**. Defective parts returned by **courier collect will not be accepted**. Replacement parts will be sent at the cost of Easy-Flo. Easy-Flo reserves the right to withhold credit for those items returned without such authorization. For warranty the owner must show a bill of sale and warranty card.
